# **Conditions of Good Cause Registration**

My Fundraiser refers to My Fundraiser NZ Limited. The Good Cause refers to the Applicant.

#### Vetting of Good Cause

- 1. The Applicant agrees to aid My Fundraiser NZ Limited in any vetting process required. This may include providing additional supporting documents or information if requested.
- 2. If information provided on the Good Cause Registration Form does not meet the criteria for a Good Cause, My Fundraiser NZ Limited has the right to refuse any application.

#### Marketing

This is largely about celebrating the Applicant's successes, which are in turn a success story for My Fundraiser.

- 3. The Applicant agrees to supply material about their fundraising for My Fundraiser to use in their marketing efforts as requested.
- 4. The Applicant agrees that these materials and information can be used as content on My Fundraiser's social media accounts, website, blogs and email newsletters.
- 5. If requested by My Fundraiser, the Applicant will make their best efforts to provide material requested. This may include, but is not limited to photos, logos and information regarding what raised funds are used for.

#### Website Listing

- 6. The Applicant agrees to be publicly listed on <u>www.myfundraiser.co.nz</u> as a Good Cause. This allows the Applicant's Good Cause to feature as an option for supporters to select when purchasing.
- 7. The applicant agrees that My Fundraiser NZ Limited can use social media and website links to promote their Good Cause on the My Fundraiser website.

#### **Fundraising Reports**

8. My Fundraiser agrees to provide monthly reports of sales, and the resulting funds raised for the Good Cause.

#### Payments

- 9. My Fundraiser NZ Limited and the Applicant agree that funds raised for the Good Cause will be 10% of full sale price of the supporter's purchase.
- 10. The Applicant accepts that raised funds will be transferred to the Applicant's nominated bank account on the 20<sup>th</sup> of the following month from which supporter purchases were made. This will be a bulk sum of all money of 10% of all purchases made to support the Applicant's Good Cause from the previous month.
- 11. My Fundraiser agrees to release all funds from purchases the prior month to the nominated bank account by the 20<sup>th</sup> of the following month.
- 12. The applicant agrees that funds raised will not be used for personal use.

# Withdrawal

- 13. The Applicant has the right to withdraw as a Good Cause at any time. This must be done in writing via email to info@myfundraiser.co.nz.
- 14. In the event of withdrawal as a Good Cause, My Fundraiser agrees to release all owing funds under the existing payment schedule.
- 15. My Fundraiser NZ Limited has the right to remove/withdraw any Good Cause.
